

PARENT AUTHORIZATION FORM

Rest Time Policy:

My child is under 12 Months of age and may sleep in a crib. Sleeping arrangements require infants to be placed on their back to sleep. The staff will transfer infants to their crib, should they fall asleep in equipment (car seat, swing, bouncy seat, etc.) other than their crib. Staff will provide supervision and monitor the infants every ten minutes as they sleep and document their findings. A crib sheet and light weight blanket will be provided from home for use during rest periods.

My child is over 12 Months of age and may sleep on a cot within the classroom. Children unable to sleep will rest quietly on their cot for no more 30 minutes and will then be offered quiet activities off of their cot. A crib sheet and light weight blanket will be provided from home for use during rest periods.

Nature Walks and Field Trips:

Part of our curriculum is to take the Infants and Toddlers on Buggy walks and the Preschool Children on Nature Walks and Field Trips. We are very fortunate to have the Waldbaum's Shopping Center and continuous sidewalk for safe exploration of our neighborhood. You will be notified in advance of our plans.

I understand that Nature Walks and Field Trips are part of the curriculum and that Kiddie Academy of Greenlawn may not be able to absorb my child in another class due to staff/child ratios and age requirements set by New York State. In the event of a Field Trip or Nature Walk, advance notification will be provided by the center so that I can either make arrangements to join my child and their class on their adventure or make alternate arrangements for the care of my child, while the class is away from the building.
